TYRONE COUNTY BYE-LAWS 2024

COISTE CHONTAE THÍR EOGHAIN

- 1 Excepting those functions reserved to the Provincial Council and the Central Council, the County Committee shall be the governing and controlling body of all the affairs of the Association within the County.
- 2 (a) In accordance with **Rial 3.9, T.O. 2023** the annual County Convention shall elect the following:
Chairperson, Vice-Chairperson, Secretary, Assistant Secretary, Treasurer, Assistant Treasurer, Coaching Officer, Officer for Irish Language & Culture, Hurling Officer and PRO. It shall also elect a representative on Central Council and two representatives on the Ulster Council.

It shall also appoint, as recommended by the outgoing County Committee,
 - (i) a Children's Officer
 - (ii) a Planning and Training Officer and
 - (iii) a **Demographics Officer**
- (b) In accordance with **Rial 3.9 (b) Exception (2), T.O. 2023**, the County Treasurer will not be subject to the maximum period of office of five years.
- (c) Nominations for conventions within the County shall be automatically withdrawn at the Convention unless the nominee indicates that he/she is standing for election.
- (d) **A member who has served five years either consecutively or cumulatively, in a specific Officership, shall be ineligible to hold that Officership for the ten year period following immediately after serving the fifth year in that Office. If a member is elected as an Officer of the County Committee 'in term', twenty-six weeks or less before Convention, that time served shall not be considered as part of the five years' period.**
- 3 The County Committee shall consist of the following:
 - (a) Officers: Chairperson, Vice-Chairperson, Secretary, Assistant Secretary, Treasurer, Assistant Treasurer, Coaching Officer, Officer for Irish Language and Culture, Hurling Officer and PRO.
 - (b) Central Council Representative (x1)
 - (c) Ulster Council Representatives (x2)

- (d) The Children’s Officer, the Planning and Training Officer **and the Demographics Officer**
- (e) Representatives of Clubs
(1 person to be nominated from each Adult Club, on nomination form issued for County Convention)
- (g) Two nominees of the Chairman and Secretary
- (g) County Referees’ Administrator
- (h) County Handball Committee Representative
- (i) County Primary Schools Committee Representative
- (j) County Post-Primary Schools Committee Representative
- (k) County Safety and Facilities Officer

Chairpersons of sub-committees, who are not members of the County Committee, may attend meetings of the County Committee, in that capacity only and without voting rights, to present progress reports on the work of their sub-committees as required by Riail 3.21(ii), T.O. 2023.

The following persons may also attend meetings of the County Committee, but shall not have voting rights. They may, subject to the consent of the Chairperson, be allowed to partake in discussions on issues relevant to their areas of interest.

- (i) the Honorary President of the Tyrone County Committee
- (ii) the Chairperson of the Tyrone Ladies Football County Committee
- (iii) the Chairperson of the Tyrone Camogie County Committee
- (iv) **the County Operations Manager**

4 APPOINTED SUB-COMMITTEES

The County Committee shall appoint the following sub-committees whose responsibilities shall be as set out in **Riail 3.19 (ii), T.O. 2023**. Membership shall be set out in these bye-laws. All members of sub-committees shall be named.

4.1 COISTE BAINISTÍ

MANAGEMENT COMMITTEE

(13 members)

It shall be responsible, subject to the overall jurisdiction of the County Committee, for the management of the affairs of the Association, including finance, between meetings of the County Committee.

To consist of the following Officers and Representatives elected at the County Convention: Chairperson, Vice-Chairperson, Secretary, Assistant Secretary, Treasurer, Assistant Treasurer, Coaching Officer, Officer for Irish Language and Culture, Hurling Officer, Public Relations Officer, two Provincial Council Representatives and the Central Council Representative.

4.2 COISTE RIALAITHE NA gCOMÓRTAS

COMPETITIONS CONTROL COMMITTEE

(13 members)

It shall be responsible for all arrangements, including the appointment of Referees, for and control of any matters arising from Games under the jurisdiction of the County Committee, including disciplinary matters other than those functions reserved to the County Hearings Committee. It shall process and make recommendations to the County Committee on the Grading of Clubs. It shall investigate and process matters relating to the Enforcement of Rules and Codes, including hearing Objections and Counter-Objections.

It shall be responsible, in the first instance, for making decisions on applications for Transfer Within the County and the Grading of Players. It shall, on delegation from the County Committee, be responsible in the first instance for making decisions on issues concerning Entitlement of Attachment to First Club. It shall consist of a minimum of five members, who shall be appointed from members of the County Committee and/or other suitable personnel, one member of the Fixtures Analyst Sub-Committee, together with the County Referees' Administrator who shall be entitled to vote only on the appointment of referees. A County Committee may delegate other plenary powers to its Competitions Control Committee, and in such cases Appeals may be made only to the Provincial Council.

To consist of a Chairperson, a Vice-Chairperson, a Secretary, an Adult Fixture Secretary, two Youth Fixture Secretaries, a Hurling Fixture Secretary, a Disciplinary Secretary for Adult Fixtures, a Disciplinary Secretary for Youth fixtures, an Assistant Secretary for Adult Referees' notifications, an Assistant Secretary for Youth Referees' notifications, one fixtures analyst and the County Referee's Administrator who shall be entitled to vote only on the appointment of referees.

4.3 ANAILÍSÍ NA gCLUICHÍ

FIXTURES ANALYST

(1 Member)

- (a) At least one Fixtures Analyst shall be appointed on the nomination of the Management Committee.
- (b) The Fixtures Analyst shall be responsible for monitoring and analysing the County Fixtures Programme on an annual basis.
- (c) The Fixtures Analyst shall present a Report to Annual Convention on fixtures played in all club competitions and make recommendations for changes in the fixtures calendar where appropriate.
- (d) This report will be submitted to the Provincial and Central Fixtures Analysis Committees annually.
- (e) A Fixture Analyst shall be appointed as a member of the County Competitions Control Committee.

4.4 AN COISTE ÉISTEACHTA

HEARINGS COMMITTEE

(9 members)

- (a) It shall adjudicate on all Disciplinary Matters where a Hearing is prescribed and requested, relating to the Enforcement of Rules and Codes arising from matters under the jurisdiction of the County Committee or the Executive Committee of a Club within the County.

Exception:

A Hearing of an Objection/Counter Objection is the function of the County Competitions Control Committee.

- (b) It shall adjudicate on Appeals that may arise from decisions of the Competitions Control Committee on applications for Transfer Within the County, the Grading of Players and Entitlement of Attachment to First Club.

(See provisions outlined in Rules 6.4(f), Code 10.8 and Rule 6.3(d) respectively).

- (c) It shall consist of a minimum of five Members who shall be appointed from Members of the County Committee and/or other suitable personnel. No Member of the Management Committee or Competitions Control Committee may serve as a member of the County Hearings Committee.

- (d) The powers of the County Hearings Committee shall be plenary powers.

4.5 COISTE NA SLÁINTE AGUS NA nÁISEANNA

It shall further make recommendations to the County Management and Finance Committees in relation to:

- (i) The development of Grounds and Facilities, including advice on available grant aid.
- (ii) Other duties as directed from time-to-time by Central Council.

The Committee shall consist of at least six members, to include The Safety and Facilities Officer (as Chairperson) and a qualified Event Controller. The remaining members should be suitably qualified in areas relevant to the terms of reference of the Committee. Other persons with the particular skill set appropriate to specific items under discussion by the Committee may be added from time-to-time and shall act as complementary workgroups.

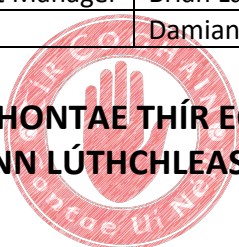

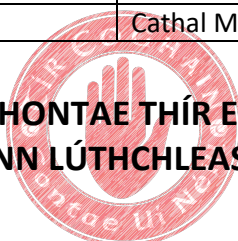

5.1 With the exception of the County Competitions Control Committee and the County Hearings Committee the County Chairperson, County Secretary, **County Treasurer and County Operations Manager** are ex-officio members of all sub-committees.

5.2 Any Appeal against a decision of the County Committee, County Management Committee, County Competitions Control Committee or County Hearings Committee shall be to the Ulster Hearings Committee.

Exception: Appeals against decisions of the CCC on Applications for Transfers shall be to the County Hearings Committee. Appeals against any decisions of CCC other than Transfers or Grading of Players (including Permissions to Play) must be made to the Ulster Hearings Committee.

6 ATTACHMENT TO FIRST CLUB (Riall 6.3 T.O. 2023)

A person seeking to become a member of the Association shall be restricted to joining a Club in the Catchment area of his permanent residence.

Where the CCC is satisfied that exceptional circumstances exist, they may consider individual applications, from a person seeking to join a club in a catchment area other than in the catchment area of his permanent residence. The procedure for making a decision on such an application shall be similar to the procedures to be followed when dealing with transfer applications under **Riall 6.4 T.O. 2023**.

7 TRANSFERS

- (a) Players seeking to transfer from one club to another within the county shall apply to the County Secretary, on the Official Transfer Form, on or before the 1ú Márta in any year. Requests for Permission to Play with a Club, in accordance with **Riail 6.7 T.O. 2023** in another parish, and any other movement between Clubs within the county shall be subject to the same 1ú Márta deadline.
- (b) The Transfer Form shall provide the full postal address, the email address where available, and the membership ID of the applicant. It shall also have the signature of the person seeking the transfer in Irish and the signature of the Secretary of the club which he wishes to join. The signature of the Secretary of the club he wishes to leave is optional.
- (c) All applications for Transfer will be dealt with in accordance with **Riail 6.4 T.O. 2023**.
- (d) The Catchment Area of a club for the purposes of this Bye-Law shall be as determined by the County Committee under **Riail 6.3 T.O. 2023**. An applicant for transfer will be required to establish, to the satisfaction of the committee concerned, that he has been permanently resident at an address within the club catchment area for a period of at least eight weeks before the date of his application for transfer.
- (e) A player will be entitled to transfer back to his First Club within the county without meeting the requirement of Permanent Residence (First Club is as defined in **Riail 6.2 T.O. 2023**).
- (f) Residence in a Club Catchment Area for the purpose of attending a Primary School, a Post-Primary School or a Third Level Educational Institution, shall not qualify as a permanent residence for the purposes of this bye-law.
- (g) For a player, up to and including Minor level, residence shall be considered to be the permanent residence of his family.
- (h) A transfer may be granted to a player to play with a Club in the area in which he works. A transfer on the grounds of work is valid only as long as the player continues to work in the club's Catchment Area, but he may complete playing in any competition which he legally commenced.

8 GRADING OF CLUBS AND PLAYERS

- 8.1 A team winning the Junior Football Championship shall be promoted to the Intermediate Grade for the following year, automatically.
- 8.2 A team winning the Intermediate Football Championship shall be promoted to the Senior Grade for the following year, automatically.
- 8.3 For a club with a Senior team and a Junior team, the County Committee may regrade a maximum of 3 players from Senior to Junior.
- 8.4 The County Competitions Control Committee shall process and make recommendations to the County Committee on applications for grading of clubs and players. All applications shall

be made to the County Secretary on or before the 1ú Márta in any year and processed in accordance with **Code 10.18 T.O. 2023**.

- 9** The above bye-laws shall supersede all previous bye-laws and motions passed at County Convention. They shall be referred to by number in all objections, appeals and such like documents wherein they are used. Motions for their amendment or deletion shall quote the number of the bye-law to be amended or deleted, and if passed by the required majority at a County Convention, shall become operative when sanctioned by Management Committee, on behalf of Central Council.

COUNTY COMMITTEE BUSINESS (Removed from Bye-laws)

MEETINGS

- 1 County Committee meetings shall be held ~~each month~~ from January to November commencing at a time and on a night to be agreed upon by County Committee members. A special meeting of the County Committee may be convened on any other date at the request of the County Chairperson and the County Secretary. A special meeting must be convened at the written request of fifteen members.

CLUBS

- 2 Subject to section (a) below, Clubs will be required to pay Affiliation and all other Outstanding Fees to the County Committee not later than 1ú Márta.
 - (a) Clubs will have the option of paying the Public Liability and Property Insurance elements of their Fees on an easy payment plan over a period of months to be determined by the County Committee.
- 3 Each Club shall submit to the County Secretary a Statement of Financial Accounts and Balance Sheet, together with a Report of the Club's Annual General Meeting on or before the March meeting of the County Committee, or on demand at any other time.
Penalty: £100 fine, if not received by 31ú Márta and, £100 fine for each subsequent month.
- 4 Each Club with a Licensed Social Centre must furnish fully audited Accounts to the County Secretary before the November meeting of the County Committee. Failure to do so will result in affiliation for the incoming season being withheld until such accounts are submitted.
- 5 The Catchment area of a Club shall normally be a Parish which, subject to County boundaries, shall be the district under the jurisdiction of a Parish Priest or Administrator.

CCC

- 6 The CCC may convene a meeting with two representatives of each affiliated Club as it deems necessary to discuss fixtures and / or discipline but any change to competitions, or regulations relating to fixtures, can only be made annually at a meeting of the County Committee.
- 7 The CCC must present to the monthly meetings of the Management Committee (April to October inclusive) its programme of Senior, Intermediate and Junior Championship fixtures, including proposed venues and times.
